**Course details and fee:** The 3 days course shall be conducted in onsite mode and the participant has to attend on all the three days. The training course involves interactive teaching & exercises. There would be an evaluation of the participants which includes daily monitoring of performance and a written examination on the last day. Only the successful participants would be considered for empanelment as NABH assessors. The fee for the training course is 15,000 + GST @ 18% (includes the cost of NABH standard and study material).

**Essential Criteria**

For Radiologists:	Degree in Medicine (M.B.B.S) with post graduate Degree in Radiology (M.D.R.D) with minimum 10-year Clinical experience in the respective field OR Degree in Medicine (M.B.B.S) with Diploma in Radiology (D.M.R.D) with minimum 12 years' experience in the respective field
For Nuclear Medicine Physician:	Degree in Medicine (M.B.B.S) with post graduate Degree in Nuclear Medicine (M.D.R.M) with minimum 10-year Clinical experience in the respective field OR Degree in Medicine (M.B.B.S) with Diploma in Nuclear Medicine (D.N.B/D.R.M) with minimum 12 years' experience in the respective field

**Desirable Criteria (for all Categories)**

- At least 5 years of experience in a NABH Accredited MIS Centre/ NABH Accredited/Certified Hospital
- Attended POI on NABH Hospital Standards/ MIS Standards
- Implementation of NABH Accreditation Standards in their respective Organization
- Higher Qualification and experience will be preferred
