Eligibility Criteria for applying for NABH Assessors Course:

For clinician: Post-graduate or MBBS with 10 years of experience of which 5

years should be in a hospital. Higher qualification in clinical

branches will be preferable.

For administrator: Post-graduate in Hospital Management with prior medical

qualification and a minimum of 10 years of experience of which 5 years being in the hospital administration at senior management

positions. Higher qualification will be preferable.

For Nursing assessor:

sing M.Sc. or B.Sc. Nursing with 10 years of experience. Minimum of 5 r: years should be in an organization wide supervisory capacity in

the hospital. Higher qualification will be preferable.

Experience of at least one year in implementation of NABH accreditation standards in their organization. Candidate with higher experience than minimum will be preferred. Candidates

having successful completion of POI on NABH Accreditation Standards or entry level standards are desirable. Participants should be proficient with the requirements of the NABH standards

and the interpretation.

Only short listed candidates shall be asked to deposit the course fee.
