**Course details and fee:** The 4 days course shall be conducted in onsite mode and the participant has to attend on all the four days. The training course involves interactive teaching & exercises. There would be an evaluation of the participants which includes daily monitoring of performance and a written examination on the last day. Only the successful participants would be considered for empanelment as NABH assessors. The fee for the training course is 20,000 + GST @ 18% (includes the cost of NABH standard and study material).

<b>Essential Criteria</b>	MDS with 10 years of experience/ BDS with 12 years of experience, out of which at least 5 years of clinical experience in a dental healthcare facility. Higher qualification in Dental clinical branches will be preferred.
<b>Desirable Criteria</b>	Experience of at least one year in implementation of NABH Accreditation standards in their organization. Candidates with higher experience than the minimum will be preferred. Additional Quality Management Certifications are desirable. Participants should be proficient with the requirements of the NABH standards and the interpretation. Candidates must have good proficiency with using internet, MS office.
