**Sub:- Suspension of empanelment of 19 Health Care Organizations (HCOs) empanelled under CGHS Delhi/NCR.**


With reference to the above mentioned matter, the undersigned is directed to draw attention to the Office Memorandum No. S-11045/36/2012-CGHS (HEC), dated 01.10.2014 and OM No. S-11011/09/2022/CGHS (HEC), dated 13.09.2022 vide which the following Health Care Organizations (HCOs) were empanelled under CGHS Delhi/NCR and to state that these HCOs were found indulging in fraudulent activities by raising fake & forged Bills, admitting beneficiaries with their family members simultaneously multiple times and periodically.
